Federal Tax Credit: Excise/Fuel Tax Refund

- Landscaping businesses pay **federal fuel taxes** (18.4¢/gallon gas; 24.4¢/gallon diesel) on fuel for off-highway equipment like mowers, blowers, and generators.
- If you use fuel not dyed for highway use, you may claim a 100% refund via IRS
 Form 4136.
- On average, landscapers recover around \$700 per year, though many fail to claim it.
- Keep a detailed fuel log—even if receipts aren't required—to substantiate your claim.

■ Common IRS Credits & General Business Tax Credits

While not unique to landscaping, these credits benefit many small businesses:

- Work Opportunity Tax Credit (WOTC) if you hire individuals from certain targeted groups.
- Research & Development (R&D) Credit, if you develop new processes or technologies—even landscaping methods or soil treatments could qualify.
- **Family leave credit** (12.5–25% of wages) for providing paid family leave through 2025.
- Small Business Health Care Tax Credit if you offer SHOP plan coverage and meet FTE and wage thresholds.

Business Deductions (vs. Credits)

While not credits, deductions reduce taxable income and are highly relevant to landscapers:

Equipment & Vehicle Expenses

- Deduct purchases of tools, supplies, machinery, and materials.
- Use **Section 179 expensing** or **bonus depreciation**: for example, in 2025 bonus depreciation is 40% of eligible assets; dropping to 20% in 2026.
- Section 179 limits were recently increased, enabling faster write-off of equipment costs (e.g. commercial mowers).

Home Office Deduction

- If you have a home office used **regularly and exclusively** for landscaping office work, you can deduct a portion of your home expenses.
- You may also deduct a proportional share of your lawn care or landscaping costs if they are tied directly to that home office use (as supported by several IRS-approved Tax Court cases).

Vehicle & Mileage

 Track business miles carefully. You can deduct actual vehicle expenses or use the IRS standard mileage rate.

Labor, Advertising, Insurance & Supplies

 Wages to employees or subcontractors, business insurance, advertising, rent, or contract labor are deductible business expenses.

Rental Property

• If you own rental properties, you can deduct landscaping maintenance and lawn care as operating expenses.

Energy-Related Credits (for properties landscaping touches)

Landscaping jobs that include **qualified energy-efficient improvements** (e.g., efficient irrigation systems, solar-powered lighting or pumps) may qualify for:

- Energy Efficient Home Improvement Credit up to 30% of qualifying costs (max \$1,200/year or \$2,000/year for heat pumps, etc.), through 2032.
- Residential Clean Energy Credit 30% credit through 2032 for solar, battery storage, geothermal, etc.

Note: some pending legislation ("One Big Beautiful Bill Act" in July 2025) proposes phasing out clean energy credits earlier—so timing matters.

Action Steps to Maximize Savings

- 1. **File IRS Form 4136** to claim your fuel tax refund.
- 2. **Keep careful logs and records**: track fuel use, office space, vehicle mileage, equipment purchases, etc.
- 3. **Leverage bonus depreciation & Section 179** to accelerate write-offs on equipment purchases.
- 4. Evaluate labor credits and hiring incentives (e.g. WOTC, family leave).
- 5. **If you perform energy-efficient installation elements**, confirm they qualify for clean energy credits.
- 6. **Consider consulting a tax professional**—especially for complex credits like R&D, and home office vs. landscaping expense attribution.

★ Key Things to Watch

- Some **energy credits may phase out earlier** if new legislation passes. Projects should start before mid-2026 to ensure eligibility.
- Home office deductions, including shared landscaping expenses, require strict documentation and exclusive use.
- **Self-employment tax (15.3%)** is payable if you're sole proprietor—but half of that is deductible.

In sum, while landscapers don't have a multitude of **industry-specific tax credits**, you can unlock meaningful savings from the **fuel tax refund**, **depreciation deductions**, and targeted business credits. Proper documentation and timing (especially on clean-energy incentives) are essential.

Key Tips for Proper Logging:

- **Separate on-road vs. off-road fuel usage.** Only *off-road* fuel is eligible for most tax refunds.
- Track each piece of equipment or vehicle separately if possible.
- Include receipts and attach them to this log.
- Keep logs **up-to-date monthly** for easier tax prep and defense in case of audit.
